Background information

Travelling Light have been making outstanding theatre for and with children and young people for over 33 years. Our mission is to inspire young people's thinking, engage their emotions and fire their imaginations.

We are based in the heart of Barton Hill and we engage with children, young people and their families in our local area and across Bristol, providing a safe and welcoming space for them to express themselves through theatre. Our thriving participation programme provides over 4,000 experiences for children and young people per year through our young people's programme, community engagement and creative learning projects.

Context of the Role

Recent investment from Big Lottery's Youth Investment Fund has enabled Travelling Light's participation programme to develop and expand. We are now reaching more young people aged 11-19 and developing our collaborations with youth and community partners across the city. Our Young People's programme now includes the following projects:

- Youth Theatre (regular provision for young people aged 4-19)
- Louder than Words (our youth theatre for young people with additional needs aged 7-15)
- Travelling Light's Youth Board

Additional Youth Investment Fund supported activity

- ActionSpeak (our new theatre group for young people with additional needs aged 16+, delivered in partnership with West of England Centre for Inclusive Living)
- Outreach programme (taster workshops for young people in a variety of settings, working with youth and community partners)
- Young Critics programme (free theatre trips for young people aged 11-19)

The Youth and Community Officer will be responsible for managing the young people's programme, ensuring all projects are delivered to the highest possible quality while maintaining equality of access for the widest possible range of children and young people.
